Evaluation of Pupil Premium Funding for Financial Year 2014-15

The Pupil Premium Funding is based on Free School Meals (FSM) eligibility but it includes both current Free School Meal pupils and those who have been on Free School Meals at any point in the last 6 years. As has been reported previously, there are also pupils who need additional support to raise their standards of achievement so the School wants to support all students whether they are entitled to FSM or not. The School is using the Pupil Premium Funding to fund 1-to-1 tuition for the students through Academic Tutoring, Learning Support Assistants and various Service Level Agreements with the Local Authority.

In order to understand where the figures shown in the datasheet derived from, a line to line explanation is given now:

Line 1: Number of Pupils

The 2012/13, 2013/14 and 2014/15 figures were taken from the School Census.

Line 2: % eligible for FSM

Once again there figures were taken from the Census returns mentioned above.

Line 3: Revenue balance brought forward from previous year

This is the carry forward figure from previous years.

Line 4: Grant Funding

This line includes the sources of income that come mainly from the Local Authority:

Line 7: Actions focused on learning in the curriculum

Line 8: Actions focused on emotional/ behavioural issues

This line includes the following expenditure: LSU Behaviour Unit (E03) Education Psychology Service (E27) SEN & Inclusion Training SLA (E27)

Line 9: Actions focused on enrichment beyond curriculum

This line includes the Year 9 Residential trip which promotes the year group team building through activities. This trip is subsidised for the benefit of the whole year group (both FSM and non FSM students) and there is a small financial contribution from the parents. The cost mentioned is the actual cost of the subsidy. There were 2 Residential trips in 2014/15, one for Year 9 and one for Year 10 (as they had missed it the previous Academic Year).

Line 10: Actions focused on families and communities

The School is very grateful to be receiving the Cass Benefits Grant from the Sir John Cass Foundation every year. Part of the grant is used to subsidise the cost of uniforms of all students who join the school at the beginning of Year 7. As the school serves an intake of many underprivileged families, we feel that this is a sensible use of the funding as we are promoting the inclusion of all pupils and also providing a secure base for raising aspirations and standards of attainment. The School pays 50% of the uniform's cost for the students who apply for the subsidy.
